7. Submission your bid

- (a) For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: https://hptenders.gov.in. Any bidder not having the DSC may obtain the same from NIC on payment of requisite fees, before the bid submission deadline.
- (b) Bids must be submitted online on https://hptenders.gov.in on or before 24.02.2023, up to 11:00 AM and the 'Technical Part' of the bids will be opened publicly online on the same day at 11:30 PM (IST). The "Financial Part" shall remain unopened in the e-procurement system until the public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered.
- (c) All Bids must be accompanied by a Bid Security as specified in paragraph 2 and shall have to be valid for 28 days beyond the validity of the bid. Procedure for submission of bid security is described in 7 (d).
- (d) The Bidder shall furnish a bid security for the amount as mentioned in the table above, using the instruments specified in ITB 19.3 and submit it online, on or before the bid submission deadline given in point 7 (b) above.
- (e) The bidders are required to submit the "Bid Document Fee" through online only in the amount as detailed in point 6 (b above through RTGS / NEFT on or before the bid submission deadline given in point 7 (b) above, as detailed below;
- 8. Technical Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend
