Any bidder not having the DSC may obtain the same from NIC on payment of requisite fees, before the bid submission deadline.
- (b) Bids must be submitted online on https://hptenders.gov.in on or before 21.02.2023, up to 11:00 AM and the 'Technical Part' of the bids will be opened publicly online on the same day at 11:30 AM (IST). The "Financial Part" shall remain unopened in the e-procurement system until the public Bid opening for the financial part.
