The Government of India, has applied for financing from the Asian Development Bank (ADB) toward the cost of **Himachal Pradesh Subtropical Horticulture, Irrigation and Value Addition Project (HP-SHIVA Project)**". Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. "Executive Engineer, Jal Shakti Vibhag, Division Thanakalan, Govt. of Himachal Pradesh" ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of "Providing Irrigation Facility under HP SHIVA Project for Bangana Block, District Una (Himachal Pradesh) – Package - 11 ("the Works").

3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

6. To download the bidding documents in English, eligible Bidders should

- The bid documents for the work of "**Providing Irrigation Facility under HP SHIVA Project for Bangana Block, District Una (Himachal Pradesh) – Package - 11**" shall be available online on the e-Government Procurement System (e-GPS) portal <https://hptenders.gov.in> from **18/01/2023**(from 04:00 PM) onwards, till **20/02/2023**, (up to 03:00 PM). The bidding document will appear under the "**Latest Active Tenders**" tab, in the portal. The Bidder can download the bid document only during the date & time mentioned above, after which the same will be removed from the list of Latest Active Tenders. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
- The bidders will pay a nonrefundable "Bid Document" fee of **INR 10,000/-** (Indian Rupees Ten Thousand Only), as given in point 7 (e), below.

7. Submission your bid

- (a) For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorized by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://hptenders.gov.in>. Any bidder not

having the DSC may obtain the same from NIC on payment of requisite fees, before the bid submission deadline.

- (b) Bids must be submitted online on <https://hptenders.gov.in> on or before **20/02/2023**, up to **03:00PM** and the 'Technical Part' of the bids will be opened publicly online on the same day at **03:30 PM (IST)**. The "Financial Part" shall remain unopened in the e-procurement system until the public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered.
- (c) All Bids must be accompanied by a Bid Security as specified in paragraph 2 and shall have to be valid for **28** days beyond the validity of the bid. Procedure for submission of bid security is described in 7 (d).
- (d) The Bidder shall furnish a bid security for the amount as mentioned in the table above, using the instruments specified in ITB 19.1 and submit it online, on or before the bid submission deadline given in point 7 (b) above.
- (e) The bidders are required to submit the "Bid Document Fee" in the amount as detailed in point 6 (b) above through Online Mode, on or before the bid submission deadline given in point 7 (b) above,
8. Technical Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.
9. The Employer will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
